

SUBJECT: Chapter Primary Delegates Count – NDA 2020

Attached in this correspondence is the National Delegates Assembly – Chapter Delegates Eligibility Form (NDA – CDEF) 2020 indicating the number of authorized delegates per chapter for the 2020 National Delegates Assembly.

Pursuant to Article V, Section 4 Chapter Formation And Reporting Requirements and Article VII, Section 2., Subsection C. Chapter Delegates, paragraphs 2C(1), 2C(4) and 2C(5)(a) of the National Constitution of Blacks In Government, Inc., and the National Board of Directors’ Policy Manual, Policy #1:00, Section E. Delegate Assembly Authorizations and Policy #1:24 Chapters and Regions Financial Reporting Requirements, the number of authorized delegates to the National Delegates Assembly (NDA) has been determined for each chapter as contained in the attachment. The criteria are summarized below:

1. The chapter must be in an active status 60 days prior to the convening of the NDA, that is, the chapter must maintain at least ten qualified regular active, dues-paying members, unless exempted by the National Board of Directors (BOD). A qualified regular member is defined as a member whose membership category is Regular Member (RM) or Regular Life Member (RLM). This excludes Chapters who have been chartered less than 60 days.
2. Any non-exempt Chapter not having ten qualified regular active dues-paying members 60 days prior to the convening of the NDA will be ineligible to have delegates.
3. The number of chapter delegates is a factor of the number of qualified Regular members (RM and/or RLM) who are in good financial standing with the Regional Council and National Organization 60 days prior to the convening of

the Delegates Assembly. Associate members are not to be counted when determining the number of authorized delegates.

51– 75	6

Over 500	40

4. National membership dues for each chapter’s qualified RMs whose membership expired on or before June 24, 2020 or for RMs and/or RLMs who are new members of the organization must have been received by the National Organization no later than June 24, 2020 (on-line, postmarked or hand-delivered).
